

# AUSC - COVID-19 Risk Mitigation

This document outlines the activities and mitigations that the Adelaide University Scuba Club (AUSC) will implement in order to minimise the risk posed by COVID-19 to its members in the conduct of club activities.

This document has been drafted and approved by the AUSC Committee and will be updated regularly as appropriate. *Table 1: AUSC Activities and Covid-19 Risk Mitigations*

<b>Activity</b>	<b>Mitigation</b>
General	<p>The Club shall comply with all SA Covid-19 Guidelines (Ref 1) which currently state the following:</p> <ul style="list-style-type: none"> <li>- Regular handwashing/disinfecting</li> <li>- Comply with the maximum numbers in rooms stated on the AUSC Covid Safe Plan (Ref. 4)</li> </ul>
Marshals	<p>As of the 21 August 2020, COVID Marshals will supervise prescribed operations, including club nights, boat dives and away trips. A COVID Marshal will:</p> <ul style="list-style-type: none"> <li>- Be 18 years of age or more</li> <li>- Have completed the required SA government training</li> <li>- Take reasonable steps to visually identify as a COVID Marshal</li> <li>- Ensure events are following requirements to both AU Sport and SA Gov</li> <li>- Report any issues direct to the executive committee in a timely manner</li> </ul>
Diving in Buddy Pairs.	<p>Divers should gear up independently and adequately check their buddies, socially distancing where possible</p> <p>Dive gear should not be shared by more than one diver, except in the case of an emergency.</p>
Tank Filling	<p>Hand Sanitiser shall be made available to those filling tanks.</p>
Boat Dives	<p>Boat diving trips are defined as Recreational Transport. Under the current SA COVID-19 Directives club boats can continue to operate. Density requirements must be adhered to ensure 1.5 meters of social distancing between every person (Appendix A)</p> <p>The Boat Handler shall record the name of each member that attends the Boat Dive for the purpose of Contact Tracing (the trip record form can be used)</p> <p>Divers should sit in the same location throughout the trip</p> <p>Divers shall wear gloves whilst transitioning onto the boat using the ladder.</p> <p>Stainless Steel contact areas on the boat shall be wiped down with a spray and wipe disinfectant after each dive.</p>

	Divers should gear up independently as far as practicable.
Gear Hire	<p>Regulators shall be sanitised using a method recommended by the Divers Alert Network [Ref 2] each time they are returned from hire, an example of an acceptable method is soaking in 1000PPM Bleach Solution for one minute.</p> <p>BCDs, Wetsuits, Tanks and any other hire gear that is unable to be appropriately disinfected shall be “Quarantined” for a week after return before being hired out to another member as it is understood that the virus is able to survive 2-3 days on hard surfaces such as stainless steel and increasingly less for soft or porous surfaces [Ref 3]</p> <p>Gear should be hired out for longer intervals of 2-4 weeks to minimise users</p>
Dive Trips	<p>Trip numbers shall be limited in accordance with SA COVID-19 Guidelines (Ref 1).</p> <p>Social Distancing guidelines shall be adhered to:</p> <ul style="list-style-type: none"> <li>- 4 square metres per person indoors</li> <li>- Everyone should attempt to stay at least 1.5 metres from others</li> </ul> <p>Shared accommodation should be avoided where possible.</p> <p>Common surfaces shall be regularly disinfected with an appropriate cleaning agent.</p>
